



The Electrical Skills Index

A constituency-based dataset, which offers regional analysis of the gap between the numbers enrolling in classroom-based electrical courses and apprenticeship starts energised the new government. It led to a Parliamentary Roundtable with the Minister for Industry and other MPs, and an invitation to feed into the new Skills England framework. We also launched a Welsh Recharging Electrical Skills Charter in The Senedd.

Achieving a sustainable and resilient future

Prior to the general election, we spent the year raising awareness with key shadow Ministers about our industry's skills shortage and the fact that a safe transition to net zero was reliant on there being enough competent and qualified electricians. This advocacy paid off after the new UK Government formed in July as ECA has been invited to work with policy makers to find solutions to the broken skills pipeline.

We also formed a strategic partnership with Content with Purpose, SELECT, ESF and IET to create a digital series 'Electrifying our Future' to continue to push for change in 2025. This campaign will emphasise the importance of electrical safety to achieve a sustainable and resilient future.
